This business offer is designed to encourage clients to adopt digital and lean business principles to increase performance and competitiveness that will help sustain and grow their Irish operations. It also supports companies on a digitalisation journey, encompassing a review of existing systems, processes and capabilities and an exploration of new opportunities in an increasingly digital world. Lean tools and techniques are helping companies across the globe to address competitiveness issues. These tools build the capability to identify problems and take an innovative approach to improvements in operations and services. Furthermore Lean tools can identify process flow efficiency and help to identify opportunities to deliver new value-added digital services or products.

The Lean/Digitalisation Business Offer has been developed for companies engaged in both manufacturing and services activities.



LeanStart Focus on Value

Up to 7 days with a Lean consultant, to introduce Lean principles, agile processes including the completion of a specific cost reduction project. In addition, the LeanStart can support companies develop a strategic roadmap for their digitalisation journey. This should encompass a review of existing systems, processes and capabilities and an assessment of new digital opportunities. Assignments typically extend over 8 weeks.



LeanPlus Performance Improvement

A medium-scale business process improvement or digitalisation project with a Lean consultant, which will result in sustained use by the company of Lean techniques, digital technologies and related methodologies and will achieve significant measurable gains in company capabilities and competitiveness. Assignments will generally take up to 6 months to complete.



LeanTransform Business Transformation

An extensive, holistic company transformation programme with an external consultancy team of international reputation. It will embed the culture and competencies necessary for on-going competitiveness gains, sustainable continuous improvement, business transformation and/or digitalisation. Assignments will typically take at least 2 to 3 years to complete.



Implementation

The Lean/Digitalisation Business Offer will commence with a diagnostic audit of current practice and performance. In relation to digitalisation projects, the relevant IDA Digitalisation Diagnostic must be completed, where appropriate. Key performance indicators will be established to achieve targeted business improvement measures based on a set of tools and methodologies tailored to suit each client's situation.
